

RESOLUTION NO. 2025-083

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WACO, TEXAS:

That notice is hereby given that a General City Election is ordered and will be held in and throughout the City of Waco, Texas, on Saturday, May 3, 2025, at which time there shall be submitted to the duly qualified resident electors of the City as to the election of a Council Member for District II, a Council Member for District IV, and a Council Member for District V for a term ending not later than two years therefrom, in conformity with the valid provisions of the Charter of the City of Waco and the laws of the State of Texas.

That the Order of Election, attached as **Exhibit “A”** and incorporated by reference herein, is hereby adopted and ordered.

That applications to have the name of a candidate placed on the ballot as to the election of a Council Member for District II, a Council Member for District IV, and a Council Member for District V may not be filed earlier than thirty (30) days before the deadline prescribed by the Texas Election Code for filing applications with the City Secretary and that the earliest date for a candidate to file same will be **January 15, 2025**, at 8:00 a.m., with the last day for filing to be **February 14, 2025**, at 5:00 p.m., in accordance with Election Code Sections 143.006 and 143.007.

That the order of the offices on the ballot shall be as follows: City Council District II, City Council District IV, and City Council District V in accordance with Section 52.093 of the Election Code.

That the City Manager is hereby authorized to execute a contract for election services with the McLennan County Elections Administrator in connection with the 2025 Joint General Election to be held on May 3, 2025, in an amount not to exceed \$30,000.00. These services shall include, but not be limited to, those services specified in the said contract, including the utilization of countywide polling locations pursuant to Section 43.007 of the Texas Election Code.

That McLennan County, City of Waco, City of Bellmead, City of Crawford, City of Gholson, City of Hewitt, City of Lacy Lakeview, City of Lorena, City of Mart, City of McGregor, City of Woodway, Bosqueville Independent School District, Crawford Independent School District, La Vega Independent School District, Lorena Independent School District, Mart Independent School District, Midway Independent School District, Waco Independent School District, and McLennan Community College shall hold a joint general election on May 3, 2025, during the hours of 7:00 a.m. to 7:00 p.m.

That the early voting locations are attached as **Exhibit “A”**, and the polling locations (referred to as “voting centers”) for City Council District II, City Council District IV, and City Council District V, attached as **Exhibit “B”**, are incorporated by reference herein and hereby respectively designated for the election on May 3, 2025.

That in accordance with Sections 122.031-122.039 and 122.091 of the Texas Election Code, the County owns the HART Intercivic’s Verity voting system that has been duly approved

by the Secretary of State and that is hereby adopted to be used for the election on May 3, 2025.

That the City Manager is hereby authorized to execute an agreement with McLennan County, City of Bellmead, City of Crawford, City of Gholson, City of Hewitt, City of Lacy Lakeview, City of Lorena, City of Mart, City of McGregor, City of Woodway, Bosqueville Independent School District, Crawford Independent School District, La Vega Independent School District, Lorena Independent School District, Mart Independent School District, Midway Independent School District, Waco Independent School District, and McLennan Community College to hold a joint election on May 3, 2025.

That personal appearance early voting shall be held by the Elections Administrator at the:

- (1) McLennan County Elections Administration Office, 214 North Fourth Street, Suite 300, Waco, Texas;
- (2) Waco Multi-Purpose Community Center, 1020 Elm Avenue, Waco, Texas;
- (3) West Waco Library, 5301 Bosque Boulevard, Waco, Texas; and
- (4) Hewitt City Hall/Library, 200 Patriot Court, Hewitt, Texas.

That the Elections Administrator shall process all applications for early voting by mail as referenced in the order of election.

That the City Manager is hereby authorized to execute any other documents in connection therewith.

That it is hereby officially found and determined that the meeting at which this resolution is passed is open to the public and that public notice of the time, place, and purpose of said meeting was given as required by law.






